# **OFFERED PROGRAMS**

RUFA, the Rome University of Fine Arts, is an Academy of Fine Arts legally recognised by MIUR (the Ministry of Education) and is included on the list of AFAM (Higher Artistic and Musical Education) institutions). It offers various study pathways leading to the Bachelor of Arts Diploma and the Master of Arts Diploma, which for the purposes of public competitions are equivalent to the Bachelor of Art degrees and Master of Arts degrees issued by universities.

#### ADMISSION REQUIREMENTS AND DURATION OF COURSES

BACHELOR OF ARTS ADMISSION REQUIREMENTS

- To enrol on the Bachelor of Arts the student must hold a high school diploma or another educational qualification obtained abroad that is recognised by RUFA as compliant with international agreements.
- The Bachelor of Arts Course lasts for three years. To enrol, the student must have acquired 180 training credits compliant with the procedures set out in the regulations for each course.

#### MASTER OF ARTS ADMISSION REQUIREMENTS

• To enrol on the Master of Arts the student must hold either the Bachelor of Arts; a university degree that satisfies the course requirements; or another educational qualification obtained

abroad that is recognised by RUFA as compliant with current legislation and international agreements.

• The Master of Arts lasts for two years. To enrol, the student must have acquired 120 training credits in addition to the 180 training credits previously acquired on the Bachelor of Arts, and recognised as valid for admission to the Master of Arts.

# MATRICULATION TO THE BACHELOR OF ARTS

Admission to the Year 1 disciplines is known as matriculation because a matriculation number is issued to the student, who must retain it for their full period of study. Admission takes place as follows:

**DIRECT MATRICULATION:** the following applicants can matriculate directly into the following disciplines:

- **Painting, Sculpture, Set Design:** applicants holding one of the following: a high school (arts) diploma (old or new classification) or a high school (applied arts) certificate;
- Design: applicants holding one of the following with final mark > 80/100: high school (arts) diploma (specialisation in Architecture/Environmental/Design/Set Design), or a Surveyor School Technical Certificate (Construction/Environmental/Territorial Planning);
- Graphic Design and Graphic Design (Comics and Illustration): applicants holding one of the following with final mark > 80/100: high school (arts) diploma (specialisation in Graphics/ Engraving techniques and art illustration/Animated Drawing and Comics, or a Technical Certificate (Graphics and Communication/Professional Graphics);
- Cinema: applicants holding one of the following with final mark > 80/100: high school (arts) diploma (specialisation in Audiovisual and Multimedia/Cinema and Photography/Audiovisual Industry Technician/Photographic image technician);
- **Photography:** applicants holding one of the following with final mark > 80/100: high school (arts) diploma (specialisation in Audiovisual and Multimedia /Audiovisual Industry Technician).

Documents required for matriculation:

- a pre-printed matriculation form (this includes online forms);
- the applicant's educational qualification in the original or as a diploma replacement certificate;
- two passport-size photographs;
- a photocopy of an identity document, and tax code;
- receipt for payment of the matriculation fee;
- receipt for payment (to (LAZIODISCO) of the regional "right to university education" fee.

**ADMISSION BY ADMISSION TEST:** applicants holding a high school diploma (with no art specialisation or a specialisation that is not appropriate for their chosen course) or who do hold a high school diploma with an appropriate specialisation, but did not gain a final mark of at least 80/100, can matriculate by passing an admission test.

Documents required for taking the admission test:

- a pre-printed application form (this includes online forms);
- a photocopy of an identity document, and tax code;
- a copy of the applicant's educational qualification, a diploma replacement certificate, or self-certification;
- receipt for payment of the admission test fee.

After passing the admission test, the matriculation application must be submitted not later than the date given on the admission test report, and attaching the following documents:

- pre-printed matriculation form (this includes online forms);
- the applicant's educational qualification in the original or as a diploma replacement certificate;
- two passport-size photographs;
- receipt for payment of the matriculation fee;
- receipt for payment (to (LAZIODISCO) of the regional "right to university education" fee.

#### MATRICULATION TO THE MASTER OF ARTS

**DIRECT MATRICULATION:** applicants holding a Bachelor of Arts Diploma or a four-year diploma (old classification) that corresponds to the course to which they are requesting admission are admitted by direct matriculation.

**MATRICULATION BY INTERVIEW:** applicants holding a Bachelor of Arts Diploma that does not correspond to the course to which they are requesting admission are admitted after passing an interview.

These students may be admitted with a requirement to make up gaps in their previous studies.

**CONDITIONAL MATRICULATION:** applicants who expect to obtain the Bachelor of Arts Diploma in the Winter Session may be conditionally enrolled in Year 1 of the Master of Arts (February 2020). If they do not obtain the expected qualification and the conditionality is not lifted, their matriculation expires.

#### **ENROLLMENT FOR YEARS AFTER YEAR 1**

Enrollment to years after Year 1 is permitted up until 30 September 2019. *Documents required for matriculation:* 

- pre-printed enrollment form (this includes online forms);
- receipt for payment of the enrollment fee;
- receipt for payment (to (LAZIODISCO) of the regional "right to university education" fee.

# **ENROLLMENT FOR NON-EU APPLICANTS**

With note of 21 March 2005 prot. no. 658 as amended, MIUR (the Ministry of Education) issued matriculation regulations for the following: non-EU nationals residing outside Italy, non-EU nationals legally residing in Italy, EU nationals wherever resident, Italians holding foreign educational qualifications at Italian universities (universities, university colleges, polytechnics) and state and non-state higher artistic and musical institutions (academies of fine arts, conservatories, and the ISIA Design School) that are authorised to issue qualifications having legal value, can apply for matriculation to the following courses:

- Bachelor of Arts;
- Master of Arts.

Pursuant to Law 218 of 31 May 1995 reforming Article 19 (2) of the Italian system of private international law, if the applicant holds dual nationality, one of which is Italian, the Italian nationality takes precedence.

Nationals of the following countries are treated identically to EU nationals:

- Norway, Iceland, and Liechtenstein (EEC Regulations nos. 1408/71, 1612/68, 574/72, and 307/1999);
- Switzerland (bilateral agreement of 21.6.1999 ratified on 17.04.2002);
- Republic of San Marino (Treaty of Friendship and Good Neighbourliness of 31.03.1939, ratified on 06.06.1939).

#### Admission for foreign applicants coming from non-EU countries and residing abroad

The following documentation is required for admission and must be submitted to the Italian consulate, or the Italian diplomatic representation, in the applicant's country of residence:

- a pre-admission application;
- two photographs (of which one must be notarised);
- educational history;
- educational qualification.

This documentation must be duly legalised. The educational qualification must be accompanied by a legalised translation and a declaration of its validity, made at the place where it was issued. The Italian diplomatic representation must deliver this documentation to: RUFA Rome University of Fine Arts, Via Benaco 2, Roma, or send it by email to: rufa@unirufa.it.

#### Admission for EU applicants, and non-EU applicants resident in Italy

EU applicants resident anywhere and non-EU applicants resident in Italy (*i.e. any of the following: non-Italians holding an Italian residence permit issued for employment or self-employment, for family reasons, for political asylum, for humanitarian asylum, or for religious reasons; non-Italians who have been legally resident in Italy for at least 1 year holding a higher education qualification obtained in Italy; non-Italians resident anywhere, holding a final diploma from an Italian school abroad or a foreign or international school operating in Italy or abroad that is subject to bilateral agreements or special regulations for the recognition of qualifications and that meet the general conditions required for admission for study purposes) can matriculate to RUFA by submitting the application form (indicating one course only), together with a residence permit (or a copy, if applying by post) directly to the RUFA Teaching Secretary's Office not later than 30 September each year.* 

Documents required for admission:

- pre-printed admission form (this includes online forms);
- educational qualification;
- two passport-size photographs;
- a photocopy of an identity document, and tax code
- · receipt for payment of the admission test fee

This documentation must be duly legalised. The educational qualification must be accompanied by a legalised translation and a declaration of its validity, made at the place where it was issued.

#### **CHANGING STUDY PROGRAM**

Students can change their study plan transferring from one Course to another at the same level by first applying to the Director of RUFA not later than 30 September 2019.

Changing study plan and transferring from one Course to another can only be horizontal. Any training credits already acquired are only recognised by the student's chosen new discipline if the new discipline accepts them, without prejudice to the obligation on the student to pass all the basic and characterizing educational activities for the full duration of the new Course. In particular cases, the regulations for individual Courses may require the transferring student to pass an admission test (and will specifically regulate any amendments to this present article). No transfers are permitted whilst disciplines are being taught.

#### TRANSFERS

# TRANSFERS TO OTHER EDUCATIONAL INSTITUTIONS

Students can transfer to another Academy by applying to the Director of RUFA not later than 30 September 2019. If required by RUFA or the other Academy, the application may be accompanied by a document proving RUFA or the other Academy's willingness to accept the application.

Beginning from the date of application to transfer to another Academy, the student's career at RUFA terminates unless they withdraw the application before sending the transfer form.

If the transfer to another Academy is accepted, RUFA will not refund any taxes, contributions, or allowances that the student has already paid.

A student transferring to another Academy can take with them the curriculum they followed at RUFA, including any exams passed and training credits acquired.

# TRANSFERS TO RUFA FROM OTHER INSTITUTIONS

Applications to transfer in from another institution at the same level, including from outside Italy, must be addressed to the Director and must be received by RUFA not later than 3 October 2019. The curriculum the student previously followed, including any exams taken and training credits acquired, must be attached to the transfer application. The student may also be required to attach the detailed programme of the other institution, to be provided by the management of that institution, for each individual discipline they studied and the total hours spent studying it.

The Academic Council, which has the power to nominate an ad-hoc committee, shall decide on whether to recognise the studies carried out by the student at the other institution, and shall indicate:

a) any study gaps identified, and if there are inconsistencies between the curricula at the other institution and the study plans activated by RUFA, any requirement to attend supplementary or preparatory pathways in order to compensate for them;

b) any training credits accruing if an excess is found to exist between the curricula at the other institution and the study plans activated by RUFA.

In all cases, students applying to transfer to RUFA from other institutions must hold the degree required for admission to any of the RUFA disciplines.

#### SUSPENSION, TEMPORARY INTERRUPTION, AND WITHDRAWAL

**Suspension of studies:** on condition that a formal application is made, the student can apply to suspend their studies for one or more years without forfeiting the educational qualification they would obtain. An application for suspension of studies can be made for the following reasons: enrolment at a foreign Academy; acceptance by another specialisation or PhD course; childbirth; hospital treatment lasting for more than four continuous months; any other serious, documented, and demonstrable reasons. During the period of suspension, the student is not required to pay the taxes and contributions and cannot take exams of any kind.

**Temporary interruption of studies:** students have the right to interrupt their studies. If at a later date they wish to exercise that right they must submit an application to the Director of RUFA attaching:

a) the curriculum they have been following;

b) payment of a proportion of the fees and contributions for each year during which they will be interrupting their studies, as shall be established by the Academic Council and the Administrative Council;

c) payment of the fees, contributions, and charges for the academic year in which the application is made (if the student intends to interrupt their studies for more than three years, the administration of RUFA may require the payment of a forfeitary lump sum).

**Withdrawal: t**he student can withdraw from the course at any time and can later enrol as a new student on the same or a different course.

Withdrawal from the course is irrevocable and the application must be made formally, explicitly, unconditionally, and without any restrictive clauses.

Students who have withdrawn can obtain certification of their academic career, which will formally specify that due to withdrawal the career is ineffective.

Any student enrolled at RUFA who decides to withdraw from the course during the academic year must pay the full fees and contributions for that academic year and will not be entitled to reimbursement of any fees and contributions already paid.

# SUBMITTING OR MODIFYING THE PERSONAL STUDY PLAN

The Personal Study Plan must be compiled in Year 1 and submitted to the Teaching Office not later than 30 November 2019. It can be varied in any of the subsequent years by the deadline of 30 September of each year. Requests for variations to the Personal Study Plan must be submitted on plain paper together with a copy of the previous version of the Plan. Students may not attend classes in the disciplines on their Personal Study Plan until it has been formally proved.

#### TRAINING CREDITS AND EDUCATIONAL ACTIVITIES

Pursuant to Presidential Decree no. 212 of 8 July 2005, the wording *"1 credit corresponds to 25 hours of commitment by the student"* means that the student commits to respect the hours of attendance (at lectures, theoretical and practical activities, and workshops), the individual learning hours (for personal study and preparing for exams) or group study (taking part in exhibitions, projects, workshops, seminars, etc).

Teaching activities takes the form of theory lessons and theoretical/practical/lab activities, subdivided into basic, characterizing and similar educational activities.

Each Course includes mandatory activities that are specific to each discipline, but students can personalise their Personal Study Plan by choosing other similar subjects from a suggested list or, with prior approval, any of the other disciplines offered by RUFA. Training credits can also be acquired from other activities freely chosen by the student that are certified and recognised by RUFA.

The activities freely chosen by the student can be:

- exams freely chosen by the student;
- attendance at seminars/talks/workshops/events in the art world and the professions;
- · undergoing internships and placements organised and promoted by RUFA;
- participating in competitions and/or exhibitions.

#### ATTENDANCE

In order to obtain training credits, attendance is obligatory for at least 80% of the total number of hours. Special attendance arrangements and alternative learning support may be provided for working, disabled, or DSA students, or those who have specific documented conditions and who have been accorded the status of not-attending student.

#### SCHOLARSHIPS

For the 2019/20 Academic Year the RUFA Administrative Council has launched a competition for awarding 25 no. **scholarships** to Year 1 Italian and foreign students studying **Bachelor and Master of Arts.** Each scholarship is for a fixed amount of  $\in$ 2,500.00 and is paid in each of the 2 or 3 legally applicable years of the Diploma Course, subject to obtaining the training credits and passing the exams in the years after Year 1. Additionally, 2 no. scholarships are awarded that cover the full amount payable for annual fees. These scholarships are as follows:

**15 no.** scholarships of  $\notin$  2,500.00 for Year 1 students who have an *ISEE* (Equivalent Economic Situation Indicator) household income not exceeding  $\notin$  36,000.00 and are a taking Bachelor of Arts in Painting, Sculpture, Set Design, Design, Graphic Design, Graphic Design (Comics and Illustration), Photography, and Cinema;

**5** no. scholarships of  $\notin$  2,500.00 for Year 1 Italian students who have an *ISEE* (Equivalent Economic Situation Indicator) household income not exceeding  $\notin$  36,000.00 and are a taking Master of Arts in Painting, Sculpture, Print making, Set Design, Multimedia Arts and Design, Visual and Innovation Design, Computer Animation and Visual Effects, and Film Arts;

**5 no.** scholarships of  $\in$  2,500.00, based on a portfolio assessment, for Year 1 foreign students taking a Bachelor of Arts or a Master of Arts;

**2 no**. scholarships for Year 1 foreign students taking a Bachelor of Arts or a Master of Arts, based on a portfolio assessment and covering the full amount payable for annual fees and attendance fees;
