

RUFA – ROME UNIVERSITY OF FINE ARTS**Plan for controlling the exposure to and transmission of the virus - PCTV***23rd of October 2021***2021/2022 ACADEMIC ACTIVITIES**

The Decree-LAW 111 of 6 August 2021 highlighted that, from the 1st of September to the 31st of December 2021, the so-called "green pass" is required to access RUFA. The "green pass" allows you to take part not only in in-person academic and curricular activities (theoretical and practical classes, exams and thesis), but also in extra curricular activities (exhibitions, talks, workshops, seminars).

The "green pass" or rather the "COVID-19 green certification - EU digital COVID certificate" is issued by the Ministry of Health and certifies one of the following conditions:

- having been vaccinated against COVID-19 (in Italy it is issued both after the first dose and after completing the vaccination series);
- having tested negative to a rapid molecular or antigen test within the last 48 hours;
- having recovered from COVID-19 over the past six months.

Those who want to access RUFA are required to achieve and exhibit the COVID-19 green certificate. The Director is responsible for random checks of the COVID-19 green certificates (Article 25, paragraph 9, first paragraph, of Legislative Decree 165/01). The check regards:

- preventive monitoring for employees and lecturers;
- sample monitoring for students.

Art. 13 of the Prime Ministerial Decree of 17 June 2021 states that the verification of the COVID-19 green certificate is carried out by reading the two-dimensional barcode using the mobile application described in Annex B, paragraph 4, of the Prime Minister's Decree. Following the opinion of the Privacy Guarantor, the Director or his/her delegate can access the data related to the "green pass".

Certificates issued in compliance with the law in force in the Member States of the European Union are recognized as equivalent if they comply with the criteria established in the memo of the Ministry of Health.

Based on this scenario, the green passes issued are valid until the 31st of December 2021 to people residing in the Republic of San Marino, even for vaccines not recognized by the EMA and / or AIFA (example: "Sputnik").

Certifications issued in a non-EU Country after a vaccination that is recognized in the European Union and validated by a Member State are recognized as equivalent if they comply with the criteria defined in the memo of the Ministry of Health".

Those who have been vaccinated with products not recognized by the European Union (example: the Chinese-made vaccine) and who need to follow the academic activities in-person will have to take a swab-test every two days and present the related certificate to obtain the green pass and access the Institution. Alternatively, they enroll can in the health care system of in the city where they study and get vaccinated, after having received positive feedback from the doctor in terms of getting vaccinated.

The vaccines recognized by the European Union and by the Italian Medicines Agency are: Comirnaty di Pfizer-BioNtech, Moderna, Vaxzevria, Janssen (Johnson & Johnson).

People who are not required to get vaccinated due to health reasons and have an appropriate medical certification are not required to show a green pass.

Students and lecturers who wish to access RUFA must:

- achieve and show the COVID-19 green certificate;
- enter the Academy wearing a mask;
- access the rooms within the scheduled time and sit in their seat while wearing a mask;
- wait for the arrival of the lecturer, for the random check of the temperature, while continuing to wear the mask.

Before starting the lesson, the lecturer or a delegate of the Director must:

- take the temperature of those present, writing it down on the electronic register;
- in case of normal body temperature, the lesson will proceed;
- in case of a temperature higher than 37.5° the student must leave the classroom if he/she is conscious, or wait for the arrival of the doctors if he/she is not conscious;
- if for any reason or due to force majeure (absence of the lecturer or the Director's delegate for health reasons), it is not possible to measure the temperature of the students, students are obliged to fill in a self-certification form provided by the front office and/or by the lecturer and/or by another employee.

Students will be able to remove their mask if the legislation in force at the time allows it and the educational needs require it, while respecting the distance and staying in the seats assigned to them. At the moment the laws require the use of the mask in all circumstances.

People with particular pathologies are exempt from the use of the mask. In this case, it is necessary for them to show a specific certificate issued by a body accredited by the National Health Service.

During the class:

- If the lecturer is in his/her chair and if the regulations allow it, he/she may not use

the mask. Class activities have been adapted to the spaces and the seats in the classroom that can be used by students are placed at the distance established by the National Scientific Technical Committee for this type of interaction;

- If the lecturer wishes to check the works and get closer to the students, they will all have to wear their masks;
- in case of particular and restricted activities (for example photo shoots, video footage or other) it is possible to not wear the mask for the time that is necessary to carry out the activity itself, while respecting the interpersonal distance of 1 meter.

INTERNATIONAL STUDENTS/LECTURERS MANAGEMENT

The general rules for traveling to / from abroad are contained in the Prime Ministerial Decree of the 2nd of March 2021. The Prime Minister's Decree continues to be based on lists of countries for which different measures are envisaged. The Ministry of Health has divided the Countries into 5 different lists, marked by the letters of the alphabet (A, B, C, D, E)

In principle, the student or lecturer who must come to Italy from abroad for educational reasons is required to:

- 1) show a certificate stating a negative test swab result at the airport. The test must be carried out in his/her Country of origin within 72 hours of departure;
- 2) if he/she doesn't need to take a plane, he/she must send a copy to the Institution;
- 3) communicate his/her residence address in Italy before departure;
- 4) after arriving in Italy, to spend a period of quarantine of 14 days starting from the date of arrival. In case of Covid-19 symptoms, he/she must notify the competent health authority;
- 5) carry out a swab at an authorized Italian center and send the results to the Institution.

Students who have undergone Covid-19 vaccination or who have recovered abroad, can contact the Italian National Health Service to request and obtain the equivalence of vaccination or recovery certifications issued by foreign Countries.

On the website of the Ministry of Foreign Affairs and International Cooperation (<https://www.esteri.it/mae/resource/doc/2021/07/circolare equipollenza certificazioni vaccini e guarigione stati terzi.pdf>) the procedures to follow the documentation to be presented and the requirements that the vaccination or recovery certificates must possess (minimum contents) are indicated.

TRAINEESHIP AND INTERNSHIP SPECIFICATIONS

Carrying out a traineeship or an internship is to be considered equivalent to the activities carried out within the Academy.

To carry out the internship or traineeship, students must obtain the green pass and show it to their employer or to their tutor at the company.

RUFA Traineeship and Internship Office is required to ask the employer or tutor at the company to guarantee that those who enter the workplace have gotten their green pass.
