

## GIOVAN BATTISTA CALAPAI AND THEODORA VAN MIERLO BENEDETTI INTERNATIONAL PRIZE

Call updated on February 28th, 2022

## Art. 1 Purpose of the call

**A-HEAD PROJECT**, the art project created and promoted by the *Angelo Azzurro ONLUS*, is proud to announce the first edition of the "Giovan Battista Calapai and Theodora van Mierlo Benedetti International Prize ".

The Prize is in memory of Giovan Battista Calapai and Theodora van Mierlo Benedetti.

Giovan Battista Calapai and Theodora van Mierlo Benedetti have been the major contributors to the connection between *Angelo Azzurro* ONLUS- whose mission is to fight the stigma surrounding mental disorders - and the arts ,the A-HEAD project was born from this connection.

Angelo Azzurro actively promotes contemporary art through the A-Head project, by ways of constant development of a hermeneutic and cognitive approach to mental illnesses and by supporting artistic researches in all their forms.

The International Prize "Giovan Battista Calapai and Theodora van Mierlo Benedetti" looks to support emerging artists: it is aimed at artists under the age of 35 and will take into consideration not just a single work submitted by the artist but all his/her artistic of the previous five years.

Submissions are free and <u>open to all citizens</u> who are resident in Italy and abroad, aged between 18 and 35 at the date of publication of this announcement, without limits of nationality, sex, ethnicity or religion.

## Art. 3 Elegibility

Submissions are open to all citizens residents in Italy or abroad, aged 18 - 35 (at the date of publication of this announcement), without limits of nationality, sex, ethnicity or religion.

## **Art. 4 Entry Requirements**

- Entry and work submission are free of charge.
- Applicants are expected to present their artistic research from the last five years
- Each applicant must submit the following documentation in Italian or English, except for the entry form that must be completed in Italian:
  - 1. Completed entry form signed by the applicant.
  - 2. Photocopy of a valid ID.
  - 3. Curriculum Vitae, maximum two pages, outlining main artistic activities and links to any website.
  - 4. A maximum of ten pages visual portfolio showing the professional and artistic activities of the past five years.

All of the documents listed above must not exceed the total of <u>20M</u>. Documents sent through Wetransfer or other similar systems with a saving and download deadline <u>will not</u> be considered

Applications must be received no later 11.59pm on 2th of May, 2022.

#### **Art. 5 Enquiries**

### **Art. 6 Selection Stages**

All the applications submitted will be subjected to a selection from the Jury. Applicants and their submissions will be evaluated by a Jury composed of experts in various fields. The winners will receive an official communication from the staff of the Prize within the deadline set by the call. The results and outcome of the Jury decision and Prizes allocation will be made public in the press.

#### **Art. 8 Prizes**

The Jury will award:

- the "Giovan Battista Calapai Prize", with a net value of € 1000.00 (one thousand euros), it will also include an A-HEAD Edizioni publication dedicated to the artistic research of the winner and coordinated by the curators and managers of the A-HEAD project.
- 2) the "Special Mention Theodora van Mierlo Benedetti" with a net value of € 500.00 (five hundred euros), it will also include an A-HEAD Edizioni publication dedicated to the artistic research of the winner and coordinated by the curators and managers of the A-HEAD project.

#### Art. 9 Award ceremony

The Award Ceremony with the relative delivery of the cash prizes will take place on a date and location that will be announced later.



The production of the A-Head publications that are part of the "Giovan Battista Calapai Award" and the "Special Mention Theodora van Mierlo Benedetti" will be agreed between the parties after the date of the Award.

#### Art. 10 General rules

Applications and documents sent in by ways other than those specified in this announcement will not be considered (art. 4). Applications for the call implies full acceptance of these regulations.

The Prize organizers reserve the right to make changes to the announcement should the need arise.

## Art. 11 Liability

The International Prize "Giovan Battista Calapai and Theodora van Mierlo Benedetti", and the Angelo Azzurro ONLUS decline all responsibility in relation of:
