assignment of n. 7 grants reserved for students from Ukraine for the academic year 2021/2022

Art. 1- Purpose and recipients

RUFA - Rome University of Fine Arts, following the humanitarian emergency in Ukraine, makes 7 scholarships available for students from Ukraine who have the university or academic qualifications needed to continue their academic studies.

This selection notice will follow the chronological order evaluation procedure, taking into account the arrival of the students at RUFA- Rome University of Fine Arts, until the 7 available scholarships are awarded.

Art.2 -Benefits of the scholarships, conditions and delivery mode

2.1 The benefits

Each scholarship entitles the holder to a monthly payment for four months of an amount ranging from Euro 150 up to Euro 400 as a reimbursement of expenses.

2.2 Reimbursable expenses

Only expenses incurred for the purchase of food, medicines, personal hygiene products, books and other materials necessary for educational activities, medical examinations, rental fees in Rome, subscriptions to local transport services are considered reimbursable.

2.3 Methods of delivery and accountability

Following evaluation, based on self-certified information through the e-form, the amount of the scholarship will be defined and communicated to the winners, which will be paid monthly and in cash. Successful students are then required to submit a bimonthly report to access the reimbursements for the following months, under penalty of forfeiture of the scholarship benefits. To access the funds, students must have attended no less than 80% of the lessons: the attendance is calculated from the moment the winners have been admitted to the courses.

Art.3 – Admission requirements

To participate in the selection it is necessary to:

- Be a Ukrainian citizen;
- Not be enrolled in another University of Academy in Italy for the academic year 2021/2022;
- To have left Ukraine due to the recent emergency situation
- to have interrupted one's academic / university course in Ukraine following the
- recent emergency situation.
- To have won the previous selection organized by this Academy and reserved only for Ukrainian students (prot. n. 60/22/D of the 22nd of March u.s.).

Art.4 - Presentation of the candidacy and award criteria

<u>Students who possess the above requirements may apply by filling in all the fields of the appropriate e-form published together with this notice and by sending it by May 16, 2022.</u> The chronological order selection involves the evaluation, depending on the date of arrival at RUFA Academy - Rome University of Fine Arts, of the data contained within the participation e-form

It is also necessary to send the following documents to the address international.students@unirufa.it:

• Certification of previous studies (or self-certification);

- Copy of a valid identity document;
- Copy of the presentation, at the Rome Police Headquarters -Immigration Office, of the request for a residence permit in Italy for Temporary protection pursuant to Article 20 of the TUI containing "*Extraordinary reception measures for exceptional events*"

Art.5 – Acceptance

Every positively assessed candidate will receive a specific communication from international.students@unirufa.it indicating the methods and timing for the acceptance of the scholarship and/or collaboration.

Art.6 - Treatment of personal data

The personal data provided with the application to participate in the call are treated in compliance with the right to the protection of personal data and the right to preservation of confidentiality and personal identity pursuant to Legislative Decree no. 30 June 2003, n. 196 and subsequent amendments and of the GDPR (EU Regulation 2016/679).
